Degree of Chevalier	<p>The Supreme Council may grant the "Degree of Chevalier" to an active member, or Senior DeMolay, who has performed unusual and meritorious service on behalf of DeMolay. The active DeMolay must have attained the age of sixteen years and have been a member in good standing of not less than two years.</p> <p>A Senior DeMolay nominee must continue to profess a belief in a Supreme Being.</p> <p>Application Document: Degree of Chevalier – Confidential Application Form</p> <p>Ritual: Degree of Chevalier Investiture</p>
Distinguished Service Award	<p>The Supreme Council, may upon application by an Advisory Council, Chapter or member of the Supreme Council, grant to any senior DeMolay or Advisor the "Distinguished Service Award" for outstanding and long-standing service to DeMolay or a subordinate Chapter for a period of not less than five (5) continuous years.</p> <p>Application Document: Distinguished Service Award - Confidential Nomination Form</p> <p>Ritual: None – public presentation "off the cuff"</p>

<p>Honour Key - Blue</p>	<p>The Supreme Council may, upon application, award a member the "Blue Honour Key" for being the Proposer of ten (10) Membership Applications accepted by a Chapter. <p>Legion of Honour - Active</p>	<p>The Supreme Council may grant the "Active Legion of Honour" to a Senior DeMolay who is over the age of thirty (30) years for outstanding leadership in some field of endeavour or for service in fraternal life, including adult service to DeMolay.</p> <p>The nominee must profess a belief in a Supreme Being.</p> <p>Application Document: Legion of Honour – Active – Confidential Nomination Form</p> <p>Ritual: Legion of Honour Investiture</p>

<p>Legion of Honour - Honorary</p>	<p>The Supreme Council may grant the "Honorary Legion of Honour" to such men who are over thirty (30) years of age, as shall be approved by it who have performed unusual and meritorious service on behalf of the Order of DeMolay, or who have evidenced a spirit of co-operation with and appreciation for the Order of DeMolay.</p> <p>The nominee must profess a belief in a Supreme Being.</p> <p>Application Document: Legion of Honour – Honorary – Confidential Nomination Form</p> <p>Ritual: Legion of Honour Investiture</p>
<p>Majority Service</p>	<p>The Majority Service is intended to recognise those who have attained their majority and have ceased to be Active Members of the Order of DeMolay.</p> <p>Application Document: None – subject to prior Chapter approval</p> <p>Email coy-sec@demolay.org.au for presentation Certificate</p> <p>Ritual: Majority Service</p>
<p>Medal of Appreciation</p>	<p>The Supreme Council, may upon application by an Advisory Council, Chapter or member of the Supreme Council, grant to any person over the age of twenty-one (21) years the "Medal of Appreciation" for outstanding service to DeMolay or a subordinate Chapter.</p> <p>Application Document: Medal of Appreciation - Confidential Nomination Form</p> <p>Ritual: None – public presentation "off the cuff"</p>

<p>Merit Bars:</p> <ul style="list-style-type: none"> • Athletics • Attendance • Civic Service • Conclave • Fine Arts • Fundraising • Health and Fitness • Installing • Journalism • Masonic Attendance • Masonic Service • Membership • Merit • Patriotism • Religion • Ritual • Safe Driver • Scholastic • Technology • Visitation 	<p>Merit Bars primarily are awards that recognise Active DeMolays for achievement in some phase of Chapter activity or in their personal lives while members of DeMolay. Merit Bars are awarded to individual members. The Advisory Council makes a final decision about whether an individual has met the requirements for each bar.</p> <p>Each Merit Bar is produced in five colors. Each color designates the number of times a DeMolay has received a bar in that category. The color designations are:</p> <ul style="list-style-type: none"> • 1st Award – White • 2nd Award – Red • 3rd Award – Blue • 4th Award – Purple • 5th Award – Gold <p>For clarity, if a member qualifies three (3) times in a particular category, he will qualify over time for the White, Red and Blue Merit Bars in that category.</p> <p>Award is assessed and approved by the Chapter Advisory Council.</p> <p>Application Document: Merit Bar Details</p> <p>Ritual: None – public presentation “off the cuff”</p>
<p>Past Master Councillor’s Meritorious Service Award</p>	<p>One of the most prestigious awards in all of DeMolay, the Past Master Councillor’s Meritorious Service Award, was designed by our founder “Dad” Frank S. Land. The award itself is an attractive gold colored medal and is granted without charge. <p>Representative DeMolay Award</p>	<p>The Representative DeMolay Award is the highest self-achievement award Active and Senior DeMolays can earn.
